Governance

Governance is the system of rules, practices, and processes by which the Association and all its Units are directed and controlled. Our rules are defined in the GAA Official Guide as the governing document of the Association and these rules apply to all units including international units except where bye-laws have been sanctioned by GAA Management Committee.

(Official Guide: Rule 3.58b)

"The affairs of World GAA shall be subject to its Constitution and byelaws as sanctioned by the Management Committee. Such bye-laws may be approved even if they do not accord with General Rule provided the Management Committee is satisfied such deviation is necessary for the promotion of the Aims and Ethos of the Association."

GAA Governance Guide

The GAA Governance Guide is available for units to measure how they meet best practice. The document focus' on the standards that we should strive to achieve in our practices and processes to ensure that we continuously live by, and observe, our core principles. It is intended that this Guide will help our units to perform to the highest standards and to offer confidence and reassurance to all who are involved in our units and who deal with them.

This Guide sets our standards to be achieved under the five main principles of Governance:

Leadership – Long term planning to outline aims for officers to achieve with clearly defined roles and responsibilities.

Exercising Control – The Executive Committee should control all GAA activities in its jurisdiction and comply with all regulatory and legal requirements in the country where they operate. Regular financial reporting and clearly documented policies and procedures are recommended.

Transparency and Accountability – The Executive committee is accountable to its members. Central GAA. DFA and other funders. It is important that decisions are taken collectively and in line with terms and conditions of funding. There should be regular engagement with stakeholders of the unit.

Operating effectively - The executive committee members are collectively responsible for all decisions made and structures and procedures should support that. Handover procedures and induction is important for officers to be fully informed of the role they are to perform.

Behaving with integrity – Executive committee members should be integrous in carrying out the duties of their role. This includes respecting confidentiality, complying with GAA Code of Conduct and declaring any Conflicts of Interest.

Achieving best practice is a continuous journey and there is advice and support available through GAA website, Tobar (Gaelic Games learning) and personnel in Croke Park.

Funder reporting: GAA and Department of Foreign Affairs

The Global Games Development Fund (GGDF) and the Emigrant Support Programmeme (ESP) is co-funded by the Department of Foreign Affairs Emigrant Support Programmeme and the GAA. The Fund provides financial support specifically for projects and initiatives that increase or improve opportunities for the Irish Diaspora and other communities abroad to play Gaelic Games. Through the provision of financial assistance, it is the aim of the Fund to support the Irish Diaspora and strengthen Irish networks and Irish identity internationally.

Communications - Each club has a designated project lead that acts as the primary contact on behalf of the project team. Primary contacts are identified on behalf of the executive of the international unit. There is an Emigrant Support Grant Administrator responsible for liaising with the DFA, club, international unit and Croke Park.

Payments - Projects must spend within the criteria of application relating to pitch rental, equipment, tournament costs, insurance, or coach education. The DFA meets with their missions and embassies from the different regions, while the World GAA office meets with the different international units to discuss each application. The GAA and DFA meet to finalise funding grants before letters of offer are sent out to clubs, and missions and units are contacted.

To receive the full award projects must sign a letter of acceptance and attend a mandatory introduction webinar. Money is paid to each unit executive to release funds at two intervals throughout the year. Projects agree to a mid-year report and an end-of-year financial and narrative report. All invoices are submitted through an invoice approval form, unit secretaries accept or reject invoices dependent within the projects spending amount and criteria.





Diaspora

The importance of the GAA to the Irish diaspora cannot be overstated. It serves as a powerful symbol of Irish identity and heritage, providing a sense of belonging and connection to Irish culture for those living abroad

For many Irish immigrants, the GAA becomes their first point of contact and a second home when they arrive in a foreign country. It offers a familiar community where they can meet fellow Irish individuals, make friends, and establish a support network. The sense of camaraderie and shared experiences creates a strong bond among members, allowing them to navigate the challenges of living away from their homeland together.

The GAA also plays a significant role in promoting networking opportunities. Its clubs and events act as meeting points for Irish people living overseas, offering a platform for professional and social connections. Networking within the GAA community can prove invaluable in forging career paths, establishing businesses, or simply seeking advice and guidance from fellow members who have already navigated similar paths.

Moreover, the GAA serves as a hub for various business interactions within the Irish diaspora. Whether it's through sponsoring local events or providing a space for Irish entrepreneurs to meet and collaborate, the GAA facilitates business opportunities and fosters economic ties among its members.

Lastly, the GAA becomes a family away from home for Irish immigrants. It offers support not only to individuals but also to families who find

themselves in a new country. The GAA's sense of community and shared values provides a support system for individuals and families to celebrate their Irish heritage together, easing the challenges of being away from their native land.

Recognising the importance of the GAA to the Irish diaspora, the Department of Foreign Affairs has shown their support through initiatives such as the Emigrant Support Programmeme, Global Games Development Fund, and Capital grant funding streams. These initiatives aim to strengthen the ties between the GAA and the Irish diaspora, ensuring that the Association continues to play a vital role in connecting Irish communities worldwide and preserving Irish culture and heritage.

Global Ireland, Ireland's Diaspora Strategy 2020-2025

- · Promote awareness of Gaelic Games abroad and support their development internationally through the Global Games Development Fund
- Promote sporting events hosted in Ireland from diaspora-based teams
- Support the engagement and status of women and girls in sport in the diaspora, in line with the National Strategy for Women and Girls

- Highlight the participation of Irish teams and athletes in international sporting events to diaspora communities
- Deepen our connection to people for whom Irish heritage is more distant, including the African American and Hispanic communities in the US, and people of Irish ancestry in Africa, the Caribbean, Latin America and other parts of the world
- Allocate resources for initiatives that aim to support women's empowerment and youth engagement among the diaspora

Central Statistics Office (CSO)

The CSO is responsible for estimating annual emigration rates and publishing related figures online. While the CSO disaggregates the total emigration numbers into Irish citizens and non-Irish individuals, it does not provide this breakdown for specific destinations. For instance, recent data indicates that approximately 63,000 individuals emigrated, with an estimated 29,000 being Irish. However, the statistics do not specify the number of Irish and non-Irish emigrants to individual destinations such as Canada or Australia.

The CSO estimates that the top four destinations for emigration in order are Britain, USA, Canada, Australia, and pre-2004 EU countries, although the figures for the latter category are not currently available. Notably, the Australian Government has seen a rise in the issuance of working holiday visas to Irish citizens, reaching 21,000 after a period of lower numbers in previous years, potentially reflecting pent-up demand post-pandemic.

In terms of the demographic profile, CSO estimates for the twelve months to April 2023 highlight that approximately 22% of the total emigrants were aged between 15 and 24, while 50% were aged between 25 and 44. It's important to note that these points serve as indicators rather than definitive trends, and the lack of further disaggregation limits the provision of detailed information beyond the primary destination countries (See Appendix 2 Emigration by year 2006-2023).



GAA Transfers & Sanctions

In 2023, a total of 3,013 players transferred to international units (See Appendix 4 Transfer Data Summary Table 2019-2023). Moreover, the number of approved sanctions for the same year amounted to 610, with 312 for USGAA, 75 for New York, 78 for Canada, and 145 for J1 (See Appendix 5 Overseas Sanctions). Adding to this, FRS Recruitment conducted a study in 2023, revealing that 52% of the 4,347 surveyed individuals expressed their consideration of moving abroad for fresh opportunities (See Appendix 6 FRS Recruitment findings). For comprehensive details on these statistics and more, the complete 2023 report is available for reference.



In World GAA, the concept of twinning partnerships strengthens the global ties of Gaelic Games by connecting each of the four provinces in Ireland—Munster, Leinster, Connacht, and Ulster—with overseas units.

This collaborative approach fosters a supportive network where international units receive bespoke and tailored assistance from their twinned province based on their specific needs.

For instance, Connacht is twinned with New York, Asia, and London, while Ulster forms partnerships with Britain, Canada, and Argentina. Leinster collaborates with Australasia, the Middle East, and Europe, and Munster is twinned with the USGAA.

The support provided spans a diverse range of activities encompassing player, coach, referees, and administrator development in both formal and informal settings.

These services, which extend beyond the list (See Table 1.4 Twinning Partnership Support), underline the commitment of the provinces to nurturing Gaelic Games on a global scale.






Diagram 1.1 Current World GAA Membership Information

Asia

Throughout the Asian continent, Gaelic Games have made significant strides since their inception in 1996. The establishment of the Asian County Board (ACB) in 2006 has played a pivotal role in the organization and expansion of Gaelic Games in the region. The Asian Gaelic Games (AGG) began in Manila and have since been hosted in various cities such as Singapore, Bangkok, Kuala Lumpur, Shanghai, Seoul, and Hong Kong. What started with four clubs has now flourished to include 23 active clubs engaging in Gaelic Football, LGFA, Hurling, Camogie, and Youth teams. Notably, the ACB has made considerable progress in developing Youth Gaelic Games, introducing the first Asian Youth Championship in 2016, now involving nearly 10 actively participating clubs in Youth Gaelic Games as of 2023.

While a full-sized GAA pitch is yet to be established in Asia, Orang Éire in Malaysia operates a slightly undersized GAA pitch. Asia GAA utilises soccer pitches for tournaments and championships are mainly played at 9-a-side. The journey of Gaelic Games in Asia is underscored by key milestones, including the founding of the Asian Gaelic Games in 1996, the establishment of the Asian County Board in 2006, and the growth of major competitions such as the Hurling and Camogie Championships, the South Asian Gaelic Games, North Asian Gaelic Games, Asian Youth Championships, and the premiere Asian Gaelic Games.

Middle East


Gaelic Games have been an integral part of the community for both Irish expatriates and individuals from other communities across the Gulf region over the past three decades. Originally affiliated with the Asia and Gulf Gaelic Athletic Association (GAA) Board, the Middle East GAA attained autonomy in 2013, establishing itself as a regional county board. With affiliated clubs in the United Arab Emirates (UAE), Oman, Saudi Arabia, Qatar, Bahrain, and Kuwait, the Middle East GAA boasts over 100 competitive teams, encompassing more than 1,000 directly affiliated members and over 3,000 associate members. The Middle East County Board plays a central role in coordinating and facilitating competitive league, championship, and test-match competitions in Men's Gaelic Football and Hurling, Ladies Gaelic Football and Camogie, and an expanding Juvenile programmeme. Notably, all Middle East Championships are contested as 11-a-side games, signalling the region's commitment to fostering the growth and development of Gaelic Games.

Founded in 2013, the Middle East GAA hosts major championships such as the Middle East GAA League and Championships, showcasing its dedication to promoting Gaelic Games in the region.

New York

Gaelic Games have had a rich tradition in New York since the late 1700s, with the official establishment of the New York Gaelic Athletic Association occurring in the latter part of 1914. This period marked a time of flourishing Gaelic Games in the city, with the inaugural championship taking place in 1915. Despite facing the challenges of two world wars and an economic depression, the Association has shown steady growth over the years. Presently, the New York Minor Board (NYMB) is thriving, boasting an impressive registration of 1,800 boys and girls, along with the successful Gaelic 4 Girls programmeme catering to individuals aged 4 to 18. The NYMB comprises 13 Youth GAA clubs, witnessing a significant 20% increase since 2010, reflecting the growth of youth Hurling and Football programmemes alongside Camogie clubs.


Furthermore, New York actively participates in the US Continental Youth Championships, sending 130 teams from the city in 2014. The region also sends youth teams to Ireland for Féile and to the GAA Higher Education championships, enhancing its international presence. A notable aspect is the influence of the NYMB on adult registrations, with over 40% of current male players being graduates of the programme or indigenous players, and nearly 66% of senior ladies' football players being American born. Additionally, more than 370 coaches have completed coaching courses, indicating a strong emphasis on developing coaching talent in the region.

In terms of the games format, all New York games are played at 15-a-side, with LGFA and Camogie leagues predominantly played at 11 or 13-a-side. Gaelic Park within the Bronx serves as the primary venue for most of New York's games, while other full-sized GAA pitches are spread across the tri-state area, including locations such as Rockland GAA, Shannon Gaels in Queens, New Haven in Connecticut, St Brendan's, Monroe and Paddy's Field, Bronx. Since its founding in 1914, New York has been a significant participant in major competitions such as the New York Championships, Junior All-Ireland, and Connacht Championship, underscoring its continued dedication to growing Gaelic Games.

US GAA

The United States Gaelic Athletic Association (USGAA) serves as the governing body for promoting Hurling, Gaelic Football, Camogie & LGFA throughout the United States (excluding NYC) and boasts a membership of 5,388 affiliated individuals. Clubs engage in year-round activities, partaking in local competitions, city leagues, regional tournaments, and the USGAA Finals across all 12 months of the year. Organized regionally into 10 Divisions including Northwest, Western, Southwest, Central, Heartland, Midwest, Mid-Atlantic, Philadelphia, Northeast, and Southeast. Certain Divisions host Championship events to determine qualification for the USGAA Finals. In addition, the USGAA places significant emphasis on youth development to foster grassroots growth and cultivate future talent. Some USGAA youth clubs actively take part in the Continental Youth Championship (CYC), a prominent annual tournament involving teams from the US and Canada.

The USGAA Championships are played at 13-a-side, with some regional tournaments featuring games at 9 or 11-a-side. The USGAA is home to several full-sized GAA pitches, including Boston GAA's Canton at the Irish Cultural Centre, Chicago GAA's Gaelic Park, Cleveland GAA at the Westside Irish American club, Philadelphia GAA's Limerick field, and San Francisco GAA's Treasure Island. Since its founding in 1959, the USGAA has been instrumental in organizing major competitions such as the USGAA Finals and the Continental Youth Championships, demonstrating a steadfast commitment to the growth and development of Gaelic Games in the United States.

WORLD

Australasia

The Australasian association serves as the governing body for Gaelic Games in Australia and New Zealand, comprising a President, eight Vice-Presidents representing eight affiliated State associations, Secretary, Treasurer, and PRO. With a rich history radiating from Irish immigrants seeking to maintain a connection with their national sport, Gaelic Football, Ladies Gaelic football, Camogie and Hurling have been integral to communities across Australia and New Zealand for many decades. Presently, the appeal of Gaelic Games transcends backgrounds, attracting participation from men, women, boys, and girls. Particularly notable is the rapid development of Ladies Football and Camogie, signalling their strong growth within the region.

The GFHAA holds recognition by the Australian Sports Commission as the National Sporting Organisation (NSO), solidifying its standing as the foremost body for Gaelic Games in the region. A paramount focus on Youth Development is evident throughout Australia and New Zealand to ensure the ongoing progression of Gaelic Games. Notably, 2023 marked the inaugural Féile tournament in Australia, hosted in Adelaide. Regional games and tournaments within the area are predominantly played at 13-a-side.

In line with many international units, the absence of dedicated full-sized GAA pitches is a shared reality in Australasia. As a result, several clubs rent grounds from AFL/Rugby facilities, adapting and lining out the grounds to match GAA specifications. Nonetheless, specific locations do feature fullsized GAA pitches, including Monarch Oval in Ingleburn, Sydney, Gaelic Park in Keysborough, Melbourne, Willawong in Brisbane, Tom Bateman in Perth, St. Mary's in Adelaide, and in New Zealand, Hagley Park in Christchurch. Since its founding in 1974, the GFHAA organizes major competitions such as the Australasian State Championships, Australasian Regional Games, Queensland League and Championships, Victoria League and Championships, New South

Wales League and Championships, South Australia League and Championships, Western Australia League and Championships, as well as leagues in Tasmania, Wellington, and Christchurch, presenting a dynamic and thriving Gaelic Games environment across the region.

GAELIC GAMES

Europe

Since its establishment with just four clubs, Gaelic Games Europe has made remarkable strides in fostering and promoting Gaelic Games across Europe. The organization oversees the participation of Gaelic Football, Hurling, Camogie, LGFA, Handball, and Rounders clubs across five distinct geographical regions. With over 3000 members in 15 countries, spanning from Moscow to Galicia, Spain, and from Oulu in Finland to Gibraltar, the organization has witnessed consistent growth and success. Notably, Spain and France in particular, have seen significant expansion in the number of clubs and membership, with a noteworthy emphasis on the inclusion of native home-grown players. Gaelic Games have even become a part of physical education curriculums in schools in Galicia and Brittany, underlining their increasing influence and integration within the region.

Gaelic Games Europe has been the host of the 15-a-side Gaelic Football Championship and Hurling Championship for several years, with the victorious teams earning the opportunity to compete in the Men's Leinster Junior Club Championships and the LGFA All-Ireland Junior Football Club Championship, respectively. Notably, the organization facilitated the first official Gaelic Football national team match between France and Italy, featuring native-born players from both countries. Additionally, a burgeoning youth programme, including the European Féile, has contributed to the strengthening of Gaelic Games in the region.

The presence of full-sized GAA pitches in Maastricht, Netherlands, and Rennes, France - both owned by the local city council - have played a pivotal role in accommodating various events and tournaments. Maastricht hosts numerous University tournaments throughout the year, while Rennes oversees the European 15-a-side tournament, determining the European representative for the Leinster Junior Club Quarter finals on an annual basis. Moreover, regional

tournaments are played as a combination of 9-a-side and 11-a-side games. Since its founding in 1999, Gaelic Games Europe has been instrumental in hosting major championships such as the European Gaelic Football Championships (Men's & Ladies), European Hurling Championship, European Camogie Championship, Champions League, and the European 15-a-Side Gaelic Football Championship (Men's & Ladies), showcasing a vibrant and thriving Gaelic Games environment in Europe.



Canada

Canada GAA adheres to the "One Club Model" and has steadily made significant progress with the establishment of new clubs across all codes, with the latest addition being the Vancouver Wolfe Tones Hurling Club in 2023 and the formation of a new Camogie Club by Cú Chulainn GAA in Vancouver. As of 2022, the organization boasted 2500 registered members with 28 affiliated clubs spread across the vast expanse of Canada. Strategically positioned Divisional Sub-Committees in Vancouver, Western Canada, Eastern Canada, and Toronto operate under elected committees, diligently organizing competitions and safeguarding the interests of affiliated clubs and members within their respective divisions. The immense geographic distances, encompassing five time zones, pose significant challenges for both the Divisional and County committees as they strive to effectively manage operations within the country. In terms of games formats, Toronto and Vancouver Divisions predominantly contest games at 15-a-side, while the Western and Eastern divisions typically engage in 11-a-side fixtures.

Since its founding in 1986, Canada GAA has played a pivotal role in hosting major championships such as the Canadian National Championships, Vancouver Championships, Toronto League and Championships, Eastern Canadian Championships, and Western Canadian Championships, underscoring its commitment to fostering the growth and development of Gaelic Games across the breadth of Canada.

Rest of the World GAA Clubs

Gaelic Games in the rest of the world, including Uganda, Kenya, South Africa, and Argentina, are positioned for continued expansion and development. The Gaelic Games community in Buenos Aires, Argentina, has witnessed the presence of two prominent clubs, both of which have actively participated in the last three GAA World Games. In Uganda, a notable growth trajectory has been observed with the formation of clubs over the past two years, particularly in nurturing and developing youth players. Argentina predominantly engages in 9-a-side games, reflecting the unique games format in the region. With a focus on sustained progress and expansion, these regions are poised to further contribute to the global landscape of Gaelic Games.








Diagram 1.10: Rest of World Club Information

COACHING & GAMES DEVELOPMENT:

This pillar focuses on promoting and developing Gaelic Games around the world. It involves creating programmes, resources, and initiatives to train players, coaches, and officials.

The goal is to spread awareness of the games and encourage participation and skill development in GAA units worldwide.

Key Performance Indicators

- Provide eight (increase) competitive game opportunities each year to all players
- Introduce two additional Coach Developers per Unit each year. This will add 14 Coach Developers each year to International Units.
- Increase number of qualified coaches in each unit
- All Units to run minimum of two Cúl Camps in 2025
- All Units to be using Fixtures Management system by 2026
- Each unit to have five additional active Referees by 2026

HEALTH & WELLBEING:

The GAA recognises the importance of physical and mental health in its members. This pillar emphasises the promotion of a healthy lifestyle, injury prevention, and overall wellbeing within the GAA community. They may introduce programmes, workshops, and initiatives to improve the physical and mental health of players, coaches, and other members.

Key Performance Indicators

- All Units to have Health & Wellbeing Officer by 2025
- Six clubs per Unit to be part of Healthy Club Programmeme 2026
- 3. 50% of clubs to have Health & Wellbeing Officer by 2026

PUBLIC RELATIONS & COMMUNICATIONS:

Effective communication plays a crucial role in the success and visibility of any organization. This pillar involves developing and implementing communication strategies to promote the activities, achievements, and initiatives of the GAA worldwide. It focuses on building strong relationships and sharing information, both internally among GAA units and externally with stakeholders, fans, and the wider public.

Key Performance Indicators

- Increase followers on all World GAA social media channels by 40% by the end of 2026 (24,000 to 33,600).
- 2. All major international unit finals to be livestreamed by end of 2026.
- 3. All units to have two newsletter publications per year by end of 2025.

OFFICER TRAINING:

This pillar recognizes the significance of competent and skilled leaders and officials within the GAA. It aims to provide training and professional development opportunities to officers and administrators in GAA units. By

enhancing their knowledge and abilities, this pillar helps improve governance, decision-making, and overall management within GAA units.

Key Performance Indicators

- . Officer training in 20% of clubs per unit by end of 2024.
- 2. All units to have their own strategic plan by the end of 2026.
- All International units using Foireann registration system by 2026

RECOGNITION (IOC & AIMS):

GAA recognition by each unit's country sporting federation: While not explicitly mentioned in the initial statement, this is an additional goal for the GAA strategy. It involves seeking recognition and affiliation by the sporting federations in each country where GAA units are present. Achieving this recognition helps establish GAA as an official and respected sporting organisation within different national contexts.

Objective:

Foster strong connections with local communities to promote the growth and longevity of GAA activities globally.

Specific Actions:

 Engage with community leaders and organisations to raise awareness about GAA and its value to the community.

- Collaborate with local schools, youth groups, and sports clubs to promote participation in GAA games and events.
- Organise community outreach programmes, such as GAA clinics, tournaments, and volunteer opportunities, to involve community members in GAA activities.
- Seek partnerships and sponsorships from local businesses to support GAA programmes and initiatives.

Progress Indicators:

- Increased community participation in GAA games and events.
- Positive feedback and support from community leaders and organisations.
 Successful collaborations with local schools, youth groups, and sports clubs.
- Increased sponsorship and financial support from local businesses for GAA programmes.

Club Pathway

To facilitate the growth and recognition of the GAA in both new and established regions, a comprehensive club pathway is currently under development. This pathway will serve as a step-by-step guide to assist clubs seeking official recognition by the GAA, ensuring a probationary period to verify adherence to GAA protocols.

Whether overseen by the board or a twinning partner, this probationary period entails the

supervision of all club activities to ensure compliance with processes and procedures over a two-year duration. As affiliate members during this transitional phase, clubs seeking official recognition will undergo a period of oversight to ensure alignment with GAA standards.

Upon successful completion of the probationary period to the satisfaction of the board or twinning partner, the club can submit an application for official membership to the GAA World Council, supported by a recommendation letter from the overseeing entity. Subsequently, the GAA World Council will review the application and decide whether to grant official membership status.

This club pathway process aims to ensure standardised growth and adherence to GAA standards across new and established regions.

IOC Recognition

In terms of the GAA's aspiration to be recognised as an Olympic sport, it's important to focus on achieving recognition by organisations like AIMS (Alliance of Independent recognised Members of Sports), getting recognised by the IOC, and ultimately achieving Olympic qualification status.


Once Olympic recognition is attained, the GAA can then reassess its goals and aspirations accordingly. It is important to acknowledge that this process is likely to take time and success is not guaranteed. Nonetheless, taking the first steps towards this goal is crucial for the GAA.

Recognition for team sports can be more complex, but by following the established criteria and exploring potential adaptations, the GAA can enhance its chances of Olympic recognition.

Ultimately, the goal should be to work towards Olympic recognition and reassess future plans based on the outcomes achieved.

COACHING & GAMES DEVELOPMENT

Assist International Units & Clubs to become self-sufficient and sustainable in all areas of Coaching & Games Development. This will be done by offering additional supports to units and clubs, increasing meaningful games opportunities for players at all levels on the GAA Player Pathway and by increasing the number of coaches and referees available to facilitate the development of players at all ages and levels.












Diagram 1.19 World GAA Projections 2026 part 1
