

### **CLG Development Fund - Sterling Account**

Deposits are accepted from all GAA units on the following basis:

- Interest is variable (currently 1.9%). The rate may vary from time to time, any variation will occur by a recommendation of the National Financial Management Committee to An Coiste Bainistí.
- The minimum deposit to open an account in the Scheme is £1,000.
- Initial confirmation of the length of time the deposit is to be held in the fund is required. Annual updates on same will need to be provided by the club.

### **Procedure for Opening a Deposit Account:**

- Details Form The GAA Unit must complete this form outlining the unit's name, address and the signatories authorised to lodge and withdraw money (minimum of two officials is required).
- Deposit Form The GAA Unit must complete a signed Deposit form indicating the amount of funds being deposited, the length of time the club intends to keep the funds on deposit (a. Less than 1 year, b. Between 1-3 years, c. More than 3 years) and the expected withdrawal date if known.
- The GAA Unit must submit a minute from the club meeting where it was decided to deposit to the GAA Development Fund.

#### **Procedure for Withdrawing Funds:**

- The GAA Unit must complete a withdrawal form indicating the amount of money they wish to withdraw, the unit's bank details for funds to be paid and what the withdrawal funds are required for.
- No withdrawals can be made from the Fund without a withdrawal form signed by at least two signatories.
- Notice Periods for Withdrawal \*\*

Lotto funds: 10 days' notice required
 0-100,000: 1 Months' notice required.
 100,000-1,000,000: 3 Months' notice required.
 Over 1,000,000: 6 Months' notice required.

<sup>\*\*</sup> Units may request a shorter withdrawal notice period. Any such requests will be reviewed and considered by the GAA Finance Director and/ or the National Financial Management Committee on a case-by-case basis.
