

CLG Development Fund – Sterling Account

Deposits are accepted from all GAA units on the following basis:

- Interest is variable (currently 1.9%) based on the ECB rate plus a margin of 1.9%. The rate may vary from time to time, any variation will occur by a recommendation of the National Financial Management Committee to An Coiste Bainistí.
- The minimum deposit to open an account in the Scheme is £1,000.
- Initial confirmation on the length of time the deposit is to be held in the fund is required. Annual updates on same will need to be provided by the club.

Procedures:

- Details of the Unit investing in the Fund must be obtained.
 - o Minute from the club meeting where it was decided to deposit to the GAA Development Fund.
 - o A copy of the most recent certified accounts of the club.
 - An indication on how long the club intend to keep the funds on deposit (a. Less than 1 year, b. Between 1-3 years, c. More than 3 years).
- The form must contain the names and signatures of a minimum of two officials authorised to lodge, transfer and withdrawmonies.
- This form must contain the entities official stamp (if available).
- All interest accruing to the entity will be calculated from the date of receipt.
- No withdrawals can be made from the Fund without a withdrawal form signed by at least two signatories.
- Deposits will be acknowledged upon receipt.
- Notice of Withdrawal

Lotto: 10 days' notice required
0-100,000: 1 Months' notice required.
100,000-1,000,000: 3 Months' notice required.
Over 1,000,000: 6 Months' notice required.
