Talks about becoming involved in Clare GAA and describes the series of events that led to the establishment of Naomh Eoin GAA and tells of the club's successes over the years. He identifies what he sees as a danger to the future of the club and outlines what he is doing to counteract it. He also discusses his time as chairman of the Clare Football County Board and reveals what he sees as his greatest achievements during his career.

08.20 Talks about the early years of the club. Tells of success in 1976 and 1977. Describes how they raised funds to go to America. Lists the games they played over there. Mentions Gaelic Park, New York.
09:50 Discusses subsequent games, telling of victories and defeats in the late 1970s and the 1980s.
10:50 Tells of becoming chairman of the Clare Football Board. Refers to club success in football across various levels.
11:24 Describes the importance of culture in the club. Refers to the use of Irish (Gaeilge). Refers to Glór na nGael. Talks about Aonach an Chláir. Mentions Rothaí Eoin Cycling Club, Hall Eoin, Teach Eoin, Coill Bhaile Eoin Athletic Club.
12:26 Talks about recent difficulties in the club and draws parallels with how it was when the club first started. Explains the different influences in the area. Refers to the commitment of the players. Mentions Shannon Rangers. Mentions Marty Morrissey. Mentions TG4.
14:56 Discusses the trip to America. Mentions Roscommon Gaels.
15:24 Talks about his current involvement in the club. Mentions becoming a county councillor.
15:59 Tells of his disappointment with the support they're getting from GAA headquarters.
16:40 Explains his ideas for Loop Head Lighthouse and the impact this would have on the area. Refers to the centralised nature of the GAA. Mentions Hook Head, Bishop's Island.
17:39 Talks about the growing popularity of soccer and rugby. Tells of his disappointment with the television coverage of
