(b) In Stage (ii) All-Ireland Qualifier Series amend the NOTE that came into effect on January 1st 2017 as follows:

"Preliminary Round

The current year's winners of the Christy Ring Cup shall qualify to play a team defeated in a Leinster Quarter-Final. The latter team shall, where feasible, be one of the two teams that qualified for the Leinster Quarter-Finals through the Leinster Qualifier Group. If, however, both of these teams advance to the Leinster Semi-Finals, the replacement shall be a team defeated by them in the Quarter-Finals. If necessary, the team to compete in this Preliminary Round shall be decided on a draw basis.

Round 1

This Round shall be comprised of eight teams and two Groups shall be formed as follows:

Group 1-The two teams defeated in the Leinster Semi-Finals and the two teams defeated in the Leinster Quarter-Finals that did not participate in the Preliminary Qualifier Round.

Group 2-The three teams defeated in the Munster Semi-Finals and Quarter-Final and the Winners of the Preliminary Qualifier Round.

The teams shall play on a knock-out basis.

A Draw for four pairings of Group 1 v Group 2 Teams, with avoidance of a Repeat Pairing, shall be made.

Venues shall be on a Home or Away basis and shall be determined by a Draw.

The four Winners shall progress to Round 2.

 c) Under Promotion and Relegation, amend the second paragraph of the NOTE that came into effect on January 1st 2017 as follows:

The Christy Ring Cup winners shall participate in the All-Ireland Qualifier Series in the current Championship Year as outlined above and shall be promoted to the Provincial Qualifier Group for the following year."

#### (i) Provincial Championships

These Championships shall be played on a Knock Out Format. Group or 'Round Robin' Formats may not be used. The winners of the Provincial Championships shall qualify for the All-Ireland Championship Quarter-Finals Group Stage.

#### (ii) All-Ireland Qualifier Series

**Round 1** -This Round shall include all the Counties that do not qualify for Provincial Semi-Finals.

A Preliminary Game(s) if required and which may be on an arranged basis, shall be played to reduce the number of teams to sixteen. An open draw shall then be made to determine the eight pairings.

**Round 2** -Each of the eight teams defeated in the Provincial Semi-Finals shall play against one of the eight winners from Round 1. A Draw shall be made to determine the eight pairings.

**Round 3** -This Round shall involve the eight winners of Round 2. Subject to the avoidance of Repeat Pairings where feasible, a Draw shall be made to determine the four pairings.

**Round 4** -Each of the four defeated Provincial Finalists shall play against one of the four winners from Round 3. Subject to the avoidance of Repeat Pairings where feasible, a Draw shall be made to determine the four pairings.

#### (iii) All-Ireland Quarter-Final Group Stage

The All-Ireland Quarter-Final Group Stage shall be on a League basis of two Groups of four teams, with each team in a Group playing the other teams once.

The Groupings in year 1 (2018) shall be as follows:

Group 1	Group 2
Team 1: Munster provincial winner	Team 1: Ulster provincial winner
Team 2: Connacht provincial winner	Team 2: Leinster provincial winner
Team 3: Ulster runner-up, or team that defeats them in round 4	Team 3: Munster runner-up, or team that defeats them in round 4
Team 4: Leinster runner-up, or team that defeats them in round 4	Team 4: Connacht runner-up, or team that defeats them in round 4

The groupings in the succeeding years shall be determined by the Central Council.

The order of fixtures shall be as follows:

#### Phase 1

Team 1 v Team 2 (venue: Croke Park)

Team 3 v Team 4 (venue: Croke Park)

#### Phase 2

Team 1 v Team 3 or 4 (venue: Home advantage for Team 3 or 4)

Team 2 v Team 3 or 4 (venue: Home advantage for Team 3 or 4)

# Phase 3

Team 1 v Team 3 or 4 (venue: Home advantage for Team 1)

Team 2 v Team 3 or 4 (venue: Home advantage for Team 2)

The Central Competitions Committee shall make the Draws for Phases 2 and 3.

#### Note:

Home Venues shall be subject to approval by the Central Competitions Control Committee (CCC) and shall meet the criteria set down by the National Facilities/Health and Safety Committee.

#### Tie-breakers:

In the event of teams finishing on equal points in a Quarter-Final Group, the tie shall be decided by the following means and in the order specified:

- (i) Where two Teams only are involved the outcome of the meeting of the two Teams in the Group
- (ii) Score difference subtracting the total Scores against from the Scores for
- (iii) Highest Total Score For
- (iv) Highest Total Goals For
- (v) A Play-Off

### (iv) All-Ireland Semi-Finals

In the All-Ireland Semi-Finals –

The Group 1 Quarter-Final winner shall play the Group 2 Quarter-Final Runner-up.

The Group 2 Quarter-Final winner shall play the Group 1 Quarter-Final Runner-up

#### (v) All-Ireland Final

#### Other matters related to the All-Ireland Qualifier Series

#### (1) Scheduling

Qualifier Games shall be played on Saturdays/Sundays as deemed appropriate by the Central Competitions Control Committee, but the Schedule of Games shall avoid conflict with the Provincial Championships schedules (including Replays), and shall also allow sufficient dates for Club Championship fixtures. Consideration shall be given to the dual involvement of Counties in both Hurling and Football, and, where feasible, avoid the same weekend.

Provincial Runners-Up shall be allowed, where feasible, a thirteen-day gap between their Provincial Final and their participation in the All-Ireland Qualifier Series.

All Games in each Round of the All-Ireland Qualifier Series shall be played over not more than two consecutive weekends, save in exceptional circumstances.

### (2) Venues

Home Venues shall be used in Rounds 1, 2 and 3 of the All-Ireland Qualifier Series, with the first Team drawn having Home Advantage.

#### Exception:

A Division 3 or 4 team drawn against a Division 1 or 2 team in the current year's National Football League shall have Home Advantage

Venues for Round 4 shall be determined by the Central Competitions Control Committee.

A sponsor's brand name(s), distinctive marks or logo shall not be displayed on shorts or on the body of a player.

# Only a County sponsor's brand name(s), distinctive marks or logo shall be displayed on the jersey and replica jersey as per specifications approved by Central Council and in accordance with sub clause (e).

(f) The total area of the sponsor's brand name(s), distinctive marks or logo on jerseys shall not exceed an area of 350 square centimetres. That area shall be calculated by measuring the total area, including background highlighting, covered from one extremity to the other. The calculation of the size does not refer to the area covered by individual letters of a name or distinctive marks or logo but to the total area. Additional branding on other area(s) of jerseys and **replica jerseys** shall be allowed as per specifications approved by Central Council.

- (i) Provincial Championships: These Championships shall be played on a Knock Out Format. A 'Round Robin' Format may not be used. The winners of the Provincial Championships shall qualify for separate All-Ireland Championship Quarter-Finals.

#### (ii) All-Ireland Qualifier Series

**Round 1** - This round will consist of a group stage contested by the sixteen counties that do not qualify for the provincial semi-finals. The group stage will be organised on a league basis with four groups of four with each team playing the other three teams once with the top two teams from each group qualifying for round two of the qualifiers. A draw shall be made to decide groups **Round 2** - Each of the eight teams defeated in the provincial semi-finals shall play against one of the eight teams who qualify from round one. An open draw shall be made to determine the eight pairings

**Round 3** - This round shall involve the eight winners from Round 2. Subject to the avoidance of repeat pairings where feasible a draw shall be made to determine the four pairings

**Round 4** - Each of the four defeated provincial finalists shall play against one of the four winners of round 3. Subject to the avoidance of repeat pairings where feasible a draw shall be made to determine the four pairings.

#### (iii) All-Ireland Quarter Finals

Each of the four winners of the provincial championships shall play against one of the four winners from round 4. Subject to the respective provincial champions not meeting the defeated finalists from their own province in this round and to the avoidance of repeat pairings where possible A draw shall be made to determine the four pairings.

#### (iv) All-Ireland Semi-Finals

A Provincial Rota system initially determined by Central Council, shall apply. If a Provincial Championship winning team is defeated in its Quarter-Final, the team that defeats it shall take its place in the Semi-Final.

#### (v) All-Ireland Final

#### Other matters related to the All-Ireland Qualifier series

(1) Scheduling - Qualifier Games shall be played on Saturdays/Sundays as deemed appropriate by the Central Competitions Control Committee, but the Schedule of Games shall avoid conflict with the Provincial Championships schedules (including Replays), and shall also allow sufficient dates for Club Championship fixtures. Consideration shall be given to the dual involvement of Counties in both Hurling and Football, and, where feasible, avoid the same weekend. Provincial Runners-Up shall be allowed, where feasible, a thirteen-day gap between their Provincial Final and their participation in the All-Ireland Qualifier Series.

All Games in Round 1 of All-Ireland Qualifier Series shall be played over not more than three consecutive weekends, with the final round of games to be played no later than the third weekend in June save in exceptional circumstances. All games in the rounds 2, 3 & 4 shall be played over not more than one weekend per round save in exceptional circumstances. (2) Venues - Home Venues shall be used in Rounds 1 of the All-Ireland Qualifier Series with all teams in each group guaranteed at least one home game and the two teams with the lowest National Football League position in each group getting two home games. Home venues shall be used in Round 2 and 3 of the All-Ireland Qualifiers with the first team drawn having home advantage.

#### Exceptions

(i) Where two teams who have already met in a provincial championship of the current year are drawn to meet in rounds 2 or 3 the winner of the provincial championship game shall have home advantage.

The above arrangements shall be conditional on Home Grounds being deemed to meet the criteria set down by the National Health and Safety Committee and the Central Competitions Control Committee. Venues in Round 4 shall be determined by the Central Competitions Control Committee. All-Ireland Quarter-Finals scheduling save for replays and exceptional circumstances provided for in Rule 6.29(a), all games in the All-Ireland Quarter-finals shall be played over not more than two consecutive weekends and shall be completed by the second weekend in August."

(a) Senior Provincial Championships in the Provinces that have to send forward Teams to compete in the All-Ireland Championships shall begin no *later* than the third weekend in May and shall be decided during that month, June and July, unless deviation is allowed by the Central Council on the recommendation of the Central Competitions Control Committee.

  - a. Three Trustees, one of whom shall be appointed [for and on behalf of[ the relevant County Committee, one of whom shall be appointed for and on behalf of the relevant Provincial Council, and one of whom shall be appointed for and on behalf of Central Council; or
  - Two Trustees, one of whom shall be appointed [for and on behalf of] the County Committee, and the other being the Corporate Trustee shall be appointed on behalf of the relevant Provincial Council and Central Council; or
  - c. One Trustee being the Corporate Trustee.
- (b) The Real Property held by the Provincial Council shall be vested as follows:
  - a. Three Trustees, two of whom shall be appointed [for and on behalf of] the Provincial Council, one of whom shall be appointed for and on behalf of the Central Council; or
  - b. Three Trustees, two of whom shall be appointed [for and on behalf of] the Provincial Council, and the other being the Corporate Trustee shall be appointed on behalf of Central Council; or
  - c. One Trustee being the Corporate Trustee.
- (c) The Real Property held by the Central Council shall be vested in the Corporate Trustee who shall be appointed to hold the Real Property for and on behalf of Central Council.
- (d) The Real Property of the Association not owned by a club or held by an Administrative Unit shall be vested in the Corporate Trustee.

# 5.5 Method of selection and appointment of Trustees to Real Property (new)

- (a) Club
  - The Executive Committee may determine whether the Corporate Trustee or other persons shall be appointed as Trustees for and on behalf of the Club for the purposes of Rule 5.4(b)(i)(a) and 5.4(b)(i)(b) and who those persons shall be.
  - A certificate signed by the Secretary of the Club shall, in favour of any person relying on same, be conclusive evidence of the determination of the Executive Committee and the identity of the Trustees.

#### (b) Administrative Units

- Where a Trustee is to be appointed for and on behalf of an Administrative Unit, the person to be so appointed shall be determined by the relevant Administrative Unit.
- A certificate signed by the Secretary of the relevant Administrative Unit shall, in favour of any person relying on same, be conclusive evidence of the determination of the relevant Administrative Unit and the identity of the Trustees.

# 5.6 Acceptance of Appointment – Declaration of Trust (new)

As required by Central Council, all Trustees of Real Property shall execute a Declaration of Trust as approved by Central Council. The terms of the Declaration of Trust approved by Central Council may be amended or replaced as determined by Central Council from time to time.

# 5.7 Removal of Trustees of Real Property (new)

- (a) Where the trustee is a personal trustee, a Trustee shall hold office until his/her retirement or death unless replaced in accordance with the provisions of this chapter.
- (b) In the case of a Club or a County Committee, the majority of the Relevant Officers, may at any time, in their absolute discretion by notice in writing remove any existing Trustee or Trustees (other than the Corporate Trustee) from his/her office as Trustee or Trustees.
- (c) In the case of a Provincial Council the President of the Association may at any time, in his absolute discretion, by notice in writing remove any existing

Trustee (other than the Corporate Trustee) from his/ her office as Trustee.

- (d) In the case of a Club, the chairperson of the Relevant Officers shall be the chairperson of the Provincial Council concerned and in the case of the County Committee the chairperson of the Relevant Officers shall be the President of the Association.
- (e) In the event of the equality of votes, the chairperson of the Relevant Officers shall have a casting vote.
- (f) As and from the date of such removal, the Trustee or Trustees, so removed shall cease to hold office as Trustee or Trustees of the property.
- (g) In the case of removal of any such Trustee or Trustees, other than in respect of Real Property held by a Provincial Council, the chairperson of the Relevant Officers, and in the case of a Provincial Council, the President of the Association for the time being is irrevocably appointed to be his/ her of their lawful attorney and in his/her or their name and on his/her or their behalf to transfer his/her of their right title interest in and to the said lands and premises or any part thereof to any other person or person or corporation and to execute all deeds and documents and do all such things on his/her or their behalf necessary for that purpose.

# 5.8 **Power of Trustees (new)**

# (a) Club

- (i) The Trustees of a Club shall have, subject to the restrictions and limitations hereinafter contained, the Statutory Powers and to the extent that they are not comprised within the Statutory Powers, the powers set out in Rule 5.2.
- (ii) Those powers are subject to the following restrictions and limitations:-
  - Before exercising any of those powers, other than a Permitted Power, the Trustees shall obtain the prior consent in writing of the Central Council and the directive of the Club.
- (iii) The power to reinvest contained in Section 20(2)(b) of the 2009 Act shall not apply.
- (iv) Without impacting on the restrictions and limitations as set out above, the Trustees shall:-

- a. account to and hold the proceeds of sale or leasing for and on behalf of the Club;
- b. account to the Club for those proceeds; and
- c. subject to such directives as may be given to them by the club, pay and discharge the proceeds to the Club.
- (v) The Trustees of the Real Property shall exercise their powers and perform their duties from time to time as directed by the Club and in accordance with this Chapter.
- (vi) The directive of a Club shall be given by a resolution of the full members of the Club, passed by a majority of the members present, entitled to vote and voting at a duly convened General Meeting and when so passed shall be binding upon all members of the Club.
- (vii) A Certificate signed by the Secretary shall, in favour of any person relying on same, be conclusive evidence that a Directive, complying in all respect with the provisions of this Rule, was duly given to the Trustees.
- (viii) Without impacting on the restrictions and limitations as set out above, the Trustees of the Personal Property shall invest and use such property in accordance with the directive of the Executive Committee, of which an entry in the minute book shall be conclusive evidence.

# (b) Administrative Units

- (i) Trustees of the Association, Trustees of Central Council, Trustees of a Provincial Council, and Trustees of a County Committee shall have, subject to the restrictions and limitations hereinafter contained, the Statutory Powers and to the extent that they are not comprised within the Statutory Powers, the powers set out in Rule 5.2 of the Official Guide.
- (ii) The foregoing powers are subject to the following restrictions and limitations:
  - a. Before exercising any of those powers, other than a Permitted Power, the Trustees shall obtain:-

- a. the prior consent in writing of the Central Council; and
- in the case of Real Property of a County Committee, the prior consent, in writing, of that County Committee; and
- c. in the case of a Real Property of a Provincial Council, the prior consent in writing of that Provincial Council.
- The power to reinvest contained in Section 20(2)(b) of the 2009 Act shall not apply.
- c. Without impacting on the restrictions and limitations as set out above, the Trustees of an Administrative Unit shall:-
  - account to and hold the proceeds of sale, licensing or leasing for and on behalf of relevant Administrative Unit
  - account to the relevant
     Administrative Unit for those proceeds; and
  - c. subject to such directives as may be given to them by the relevant Administrative Unit, pay and discharge the proceeds to the relevant Administrative Unit.
- (ix) The Trustees of the Real Property shall exercise their powers and perform their duties from time to time as directed by the relevant Administrative Unit and in accordance with this Chapter.
- (x) The directive of an Administrative Unit shall be given by a resolution of the full members of the relevant Administrative Unit, passed by a majority of the members present, entitled to vote and voting at a duly convened General Meeting and when so passed shall be binding upon all members of the Administrative Unit.
- (xi) A Certificate signed by the Secretary of the relevant Administrative Unit shall, in favour of any person relying on same, be conclusive evidence that a Directive, complying in all respect with the provisions of this Rule, was duly given to the Trustees.

(xii) Without impacting on the restrictions and limitations as set out above, the Trustees of the Personal Property shall invest and use such property in accordance with the directive of the relevant Administrative Unit, of which an entry in the minute book shall be conclusive evidence.

# (c) Consent of Central Council

- Central Council may from time to time adopt or vary procedures for the consideration of applications in connection with and the giving of consent for the purposes of this Chapter and any matters incidental thereto. Those procedures may include the delegation of some or all of those functions to a committee, officer or employee of the Association.
- (ii) In giving its consent under clause (i) hereof, such consent may be issued subject to such particular or general conditions as Central Council (in its sole discretion) requires.

#### 5.9 **Proceedings of Trustees (new)**

- (a) Where the Corporate Trustee is a Trustee, but not the sole Trustee, the chairperson of Trustees shall be such person as is nominated by resolution of the board of the Corporate Trustee to act as its representative at meetings of Trustees. Such a nomination may be for meetings generally of Trustees, for meetings of specific Trustees or for one or more specified meetings. One or more persons may be nominated to act as substitutes or alternates.
- (b) Where the Corporate Trustee is not a Trustee:-
  - (i) in the case of a Club, or County Committee, the chairperson shall be the Trustee nominated by the relevant Provincial Council; or in his/her absence, the Trustee thereof for the time being nominated by the relevant County Committee; and
  - (ii) in the case of a Provincial Council, the chairperson shall be the Trustee nominated by Central Council, or in his/her absence, one of the other trustees as agreed between them.

- (c) The chairperson of the Trustees shall be entitled to a casting vote in the event of a tie.
- (d) Trustee meetings shall be duly summoned by the chairperson and at least five days notice of the time and place of such meeting shall be given and every notice of a meeting shall state the place, day and hour of the meeting.
- (e) Every question of fact at any such meeting shall be decided by a majority vote of the Trustees present and voting at such meetings.
- (f) Save where the Corporate Trustee is the sole
   Trustee, the quorum for a meeting of Trustees shall
   be two, one of whom shall be the Corporate Trustee.

#### 5.10 Dealings with Third Parties (new)

- (a) No purchaser, mortgagee or other person or entity dealing with the Association or a Unit shall be concerned to enquire whether the powers of the Association or the Unit exercised or purported to be exercised by its trustees have been validly exercised.
- (b) Any instrument executed by a Trustee, acting on behalf of the Association or a Unit, when entering into such contracts shall state that he is the Trustee acting on behalf of the Association or the relevant Unit, under the powers contained in this Chapter.
- (c) Where the consent or directive of a Unit or officer of the Association is required, a certificate signed by the secretary for the time being of that Unit, by the Director General or by any other person authorised by the Director General in that behalf shall in favour of any person relying on same, be conclusive evidence and binding in respect of any third party, that the required consent or directive, complying in all respects with the provisions of this rule, was duly given.

# 5.11 Indemnity (this was formerly Rule 5.3 (g) and its content is unchanged)

Each unit and the Association shall indemnify and save harmless a Trustee in respect of any loss or out of pocket expenses bona fide incurred by him in or about the execution of his powers and duties.

# 5.12 Penalty (this was formerly the final clause of Rule 5.3 and its content is unchanged)

A Unit failing and refusing to comply with the provisions of this Chapter shall be suspended until compliance is agreed and, subject to reasonable time allowed, effected.

# 5.13 Exclusion (this was formerly Rule 5.4 and its content is unchanged)

Bookmaking shall not be permitted within Association property. A member breaching or aiding the breach of this Rule shall be suspended for 24 weeks.

#### 5.14 Interpretation (new)

In this chapter, the following terms shall have the following meanings:-

"Administrative Units" means a Unit other than a Club.

"Intellectual Property" means all intellectual property rights of any and every sort, including without limitation patents, trade marks design rights, copyright and related rights, internet designations (including domain names) for the full term of such rights and including any extension to or renewal of the terms of such rights and all rights or forms of protection of a similar nature or having similar effect to any of these which may exist anywhere in the world.

"Permitted Power"

means each of the following:-

- The power to grant [or receive] a lease for a term of less than five years;
- The power to enter into a hiring agreement;
- Any of the powers set out in Rules 5.2(b),(e),(f) of the Official Guide exercised in the ordinary course of activity of the Association or the Relevant Unit.
- Any other power (from time to time prescribed as a Permitted Power for the purposes of this Chapter) by the Management Committee of Central Council

Committee of Central Council . means the property of a moveable nature, comprising all playing or sporting equipment, as well as all stock in trade and money and Intellectual Property or other assets not classified as fixtures or fittings on Real Property. means property of an immoveable nature, comprising any playing pitches, grounds or buildings, whether of leasehold of freehold tenure, with all fixtures or fittings attached thereto and used therewith, including (until otherwise directed by the relevant Unit, the proceeds of sale of such property).

subject to such conditions

or limitations as may be specified by the Management

"Relevant Officers"

"Trustee(s)"

"Personal Property"

 in relation to a Club, the chairperson of the relevant Club, the chairperson of the relevant County Committee and the chairperson of the relevant Provincial Council; and

means:-

- in the relation to a County Committee the chairperson of the relevant Provincial Council and the President of the Association; and
- in relation to Provincial Council, the President of the Association.

**"Statutory Powers"** means the powers contained in Part 4 of the 2009 Act.

means the Trustees of a Unit or Units as appointed from time to time in accordance with this Chapter.

"the 2009 Act" means The Land and Conveyancing Law Reform Act 2009.
