In special circumstances, and with the support of a three fifths majority of its members, the Central Council may summon a Special Congress. A Special Playing Rules’ Congress may be called by Central Council to meet the provisions of Rule 3.40(d).

A Special Congress that is held within a forty-eight week period following an Annual Congress shall not change a decision made at that Annual Congress.

INTER-COUNTY

Minor (Under 18): A player shall have celebrated his 17th birthday prior to January 1st and his 18th birthday on or after January 1st of the Championship year.

Under 17: A player shall have celebrated his 16th birthday prior to January 1st and his 17th birthday on or after January 1st of the Championship year.

Under 21 (Football) A player shall have celebrated his **18th birthday** prior to January 1st and his **21st birthday** on or after January 1st of the Championship Year. A player who plays an Inter-County Senior Football Championship game at any stage in a current Championship Year shall be ineligible to participate in the Inter-County **Under 21** Football Championship in that year until after his County Senior football team has been eliminated from the Inter-County Championship.

Such a player may only play in either the Inter-County Senior Hurling Championship (Tier 1) or the Inter-County U20 Hurling Championship in each seven-day period (Friday morning to the following Thursday night). Coming on as a substitute constitutes playing a game.

Clubs shall be deemed exempt from this rule by their County Committee in the following circumstances:

(i) any exclusively football Club that can demonstrate that it's Under 7, Under 8, Under 9 and/or Under 10 Players are afforded hurling at an exclusively hurling Club or dual code Club;

or

(ii) any Club that, by sheer demographics, can demonstrate it does not have the numbers to comply.

Penalty for Breach: Fine of €250 for the first year of non-compliance by any Club, with the fine to double for each consecutive year of non-compliance.

In addition, that Riall 6.17 T.O. 2022 be amended to add the following definitions for the age grades mentioned above:

Under 10: A Player shall have celebrated their 7th birthday prior to January 1st. and their 10th birthday on or after January 1st. of the Championship Year

Under 9: A Player shall have celebrated their 6th birthday prior to January 1st. and their 9th birthday on or after January 1st. of the Championship Year

Under 8: A Player shall have celebrated their 5th birthday prior to January 1st. and their 8th birthday on or after January 1st. of the Championship Year

Under 7: A Player shall have celebrated their 5th birthday prior to January 1st. and their 7th birthday on or after January 1st. of the Championship Year

(Part 1)

Amend Rule 6.21 5 (c) to read as follows:

5 (c) Except where provided for otherwise in these Rules, in County Bye-Law or in Competition Regulations, when Teams finish with equal League Points for Qualification for the Concluding Stages or for Promotion or Regulation, the tie shall be determined by the following criteria and in the order specified :

- (i) The higher number of League Points obtained in the ‘Head-to-Head’ games defined as the games in which the teams involved in the tie have played each other.
- (ii) The higher Scoring Difference (subtracting the total Scores Against from total Score For) in the ‘Head-to-Head’ games.
- (iii) The higher Scores For in the ‘Head-to-Head’ games.
- (iv) If the application of criteria (i) to (iii) results in a team(s) being successful or eliminated but there is still a relevant tie to be decided, criteria (i) to (iii) is to be repeated for the ‘Head to Head’ games only of the still tied teams.
 - (v) The higher Scoring Difference in all games in the League Group.
 - (vi) The higher Scores For in all games in the League Group.
 - (vii) A Play-Off.

Exceptions to (c): Except where provided for otherwise in County Bye-Law or Competition Regulation, Regulations (i) to (vi) inclusive above shall not apply to Under 17 or younger age grade competitions.

Delete Section (d) as its contents are covered by criteria (ii), (iii), (iv) and (vii).

Current Section (e) to become **Section (d)**.

(Part 2)

Add to 6.21 (5) (c):

Where a team’s total Scores For and total Scores Against record is affected by there not being a score for a game consequent on a walk-over, retirement, disqualification or loss of game on a proven objection, an Average Scores For and an Average Scores Against achieved by the team in its other games played (in Head to Head games or All Games in the Group, as applicable) shall be applied to the game concerned and calculated as follows: If it arises where a ‘Head-to-Head’ scores criteria is applicable, the team’s Scores For and Scores Against made in the ‘Head-to-Head’ games played shall be separately totalled and both the Scores For and Scores Against totals shall be separately divided by the number of ‘Head to Head’ games the team has actually played.

If it arises where a scores criteria involving all games in the League Group is applicable, the team’s Scores For and Scores Against made in all games played shall be separately totalled and both the Scores For and Scores Against totals shall be separately divided by the number of all games the team has actually played.

(a) Players' Injury Fund

Council may make arrangements for the provision of a Players' Injury Fund for registered playing members of affiliated units of the Association within Ireland and Britain'. The Fund shall be administered in accordance with the terms and conditions of the Fund as may be determined from time to time. A team shall not be permitted to participate in any competition or game whatsoever under the jurisdiction of the Association unless they are in compliance with the terms and conditions of the Injury Fund. Failure to fulfil a fixture as a result of such non-compliance shall result in the forfeiture of the game. Any member or unit of the Association found, following investigation by Central Council, to have made, or assisted in the making of, a fraudulent claim under the Fund shall be deemed to have discredited the Association and shall be liable to penalties set out in Rule 7.2(e).

(3) Amend to include the following paragraph:

(b) Property & Liability Insurance

Central Council shall centrally procure and administer Property and Liability Insurance and additional insurance covers as may be required and available for affiliated units of the Association within Ireland and Britain and shall seek to equitably apportion and collect the relevant insurance premiums across those units to the extent possible

That Rule 6.28 (B) (i) – Provincial Championships – Official Guide Part 1 (page 109) be amended to read:

The Provincial Championships of Munster and Leinster shall have a combined maximum of eleven teams, which shall be divided on a Provincial basis into two groups of six and five teams respectively.

The number of teams (i.e., six or five) competing in each of the two Provincial Championships shall be determined from year to year on the basis of the outcome of the Promotion and Relegation process in respect of Tier 2.

Munster Counties shall play in the Munster Championship and all other eligible Counties shall play in the Leinster Championship.”

Each group shall be played on a Round Robin basis. The group of six will have three home games and two away games, the group of five shall have two home and two away games.

The Counties finishing in the top two places in each Provincial Championship Group shall qualify for their respective Provincial Final.

6.28 B (iv) Relegation

The bottom team in the Provincial Championship group of six teams shall be relegated to the Tier 2 Championship.

6.28 C Promotion and Relegation: (Tier 2 Championship)

The winner of the Joe McDonagh Cup shall be promoted to the Senior Hurling Championship Tier 1 and take part in the Provincial Championships in the following year. If the winner is from Munster, they shall play in the Munster Championship, and if the winner is not from Munster, they shall play in the Leinster Championship.

- (p) A Council or Committee which imposes a Suspension or other Penalty for a Category VI (ii) Infraction shall have the power, on one subsequent occasion, to reduce the penalty imposed on application of the Player affected, where that Player can satisfy the Council or Committee concerned that he has completed an appropriate course of training or education. Any such reduction shall result in a penalty of not less than
 - (i) where the Player is over 18 years, a 24 Week Suspension in all Codes and at all Levels together with a Four Match Suspension in the same Code and at the same Level, applicable to the next games in the same Competition, even if one or more games occur(s) in the following year's competition.
 - (ii) where the player is 18 years or under, a 12 Week Suspension in all Codes and at all Levels together with a Two Match Suspension in the same Code and at the same Level, applicable to the next games in the same Competition, even if one or more games occur(s) in the following year's competition.

Read as follows:

Only a Full Member who has paid his annual Club subscription by the due date set by the Executive Committee of the Club. **(which shall be on or before March 31st** each year) shall be eligible to vote at, nominate for, or seek election to the Executive Committee at any following General Meeting of the Club held up to and including the due date for payment of the annual Club subscription in the following Membership Year. The onus is on the member to prove he paid his membership subscription.

- (b) That Rule 4.1 – Official Guide Part 1 – Elective Office (page 63)** be amended to read as follows:

Only a Full Member who has paid his annual Club subscription on or before 31st March in a membership year shall be entitled to be nominated for or elected to any Elective Office referred to in the Official Guide arising in the same membership year. The onus is on the member to prove he paid his membership subscription.

- (c) That Article 6.2 of the Club Constitution – Official Guide Part 1 (page 176)** be amended to read as follows:

The determined Annual Subscription shall be payable on election and thereafter annually, in advance of the date and in the manner decided by the Executive Committee. The date set shall be a date on or before March 31st each year.

The Central Council shall consist of the President, the Director General (without voting rights), President-elect, if in office; the immediate past President for the year following his term as President, the Vice-Presidents, being the **Chairpersons** of the Provincial Councils (**who shall take membership at the conclusion of the Annual Congress following their election**), two Representatives of Congress, a Representative of World GAA, and a Representative with voting rights of each of the following – each County in Ireland; Britain; the London County Committee; the USGAA Board; the New York Board; the European Board; GAA Handball; the Higher Education Council; the All-Ireland Post Primary Schools’ Council; the All-Ireland Primary Schools’ Council and the Gaelic Players’ Association and a Representative without voting rights from each of the Camogie Association and the Ladies Gaelic Football Association.

A member of the Council shall not hold office as a representative of the same unit for more than five years. A year’s term shall be from immediately after an Annual Congress to the conclusion of the next Annual Congress. If a member is elected as a Representative on the Council ‘in term’, twenty-six weeks or less before the next Congress, that time served shall not be considered as part of the five years’ period.

- (d) Where a case arises in relation to an entitlement to becoming a member of, or be attached to, a Club (hereafter to be the First Club), the County Committee shall delegate consideration of such case to its Competitions Control Committee for resolution.

If requested by any party involved in the case, the Competition Control Committee shall give all parties concerned the opportunity of making observations for consideration within a specified period and/or of attending at a convened hearing to outline their respective positions on the case.

The Competitions Control Committee shall make its decision in accordance with Rule and County Bye Law.

An appeal against the decision of the Competitions Control Committee on the case may be made in writing by an aggrieved party to the County Hearings Committee. It shall be made within three working days of the receipt of notification of the decision.

It shall state the grounds on which the appeal is being made and shall be signed by the appellant player or in the case of a Club, by its Secretary. Other formalities regarding submission of Appeal (e.g. provision of duplicate copy, fee) outlined in Rule 7.11 (f) to (i) are not applicable in this case. All other relevant sections of Rule 7.11 shall apply. An Appeal may only be upheld on the basis of the provisions outlined in Rule 7.11 (o).

A member holding any Elective Office referred to in the Official Guide shall not misappropriate Association funds or disburse them in a manner other than in the purposes for which the funding was provided or intended.

Penalty: Permanent Debarment of the member from holding any Elective Office referred to in the Official Guide.
